

## **SUMMARY ANNUAL REPORT**

### **For Farella Braun And Martel LLP Health And Welfare Plan**

This is a summary of the annual report of the Farella Braun And Martel LLP Health And Welfare Plan, EIN 94-1527242, Plan No. 501, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Insurance Information**

The plan has contracts with California Physicians Service, Vision Service Plan, Curalinc, Kaiser Foundation Health Plan, Inc., Life Insurance Company Of North America, Delta Dental Of California, Unum Life Insurance Company Of America and Standard Insurance Company to pay Medical, Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Long Term Care, Business Travel Accident and WELLNESS claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$4,011,856.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2024, the premiums paid under such "experience-rated" contracts were \$416,473 and the total of all benefit claims paid under these contracts during the plan year was \$165,222.
